

Date of receipt and mode of submission EOI paper: The vendors have to submit the sealed papers in complete shape through Registered Post /Speed Post. the last date of receipt of EOI paper is **20.02.2024** (5.00 PM). The undersigned will not be responsible for postal delay if any or non-receipt of the paper in time.

Date of Opening of EOI: The EOI papers shall be opened on **21.02.2024** at **11.00 AM** in Panchayat Samiti, Mathili in presence of the Vendors or their authorized representatives having written authorization for the purpose and the Tender Committee.

Terms & Conditions

- 1- The authorized vendor will supply the items in respective GP Headquarters in its own arrangements.
- 2- The complete setup shall need to be supplied within **07 (Seven) days** from the date of written order for commencement of work/supply
- 3- In case of delay in supply the penalty would be imposed by the Tendering Authority.
- 4- The vendor should submit Self attested copy of GST Registration Certificate along with up-to-date GST return filing document, failing which the EOI Paper will be liable for rejection
- 5- Overwriting/Correction is not allowed, failing which the EOI Paper will be liable for rejection
- 6- The vendor should submit Self-attested copy of PAN card failing which the EOI Paper will be liable for rejection
- 7- The selected vendor/ supplier will have to submit Performance security deposit of 3% of the contract value in shape of Demand Draft drawn in any Nationalized Bank/ Scheduled Bank in favour of **Block Development officer, Mathili** payable at Mathili. The performance security deposit shall be released after three months of receiving the materials in good condition. No interest shall be paid on the Performance security deposit at the time of release.
- 8- The Payment will be released after 15 days of receiving the materials with the proper invoice as well as proper quality verification by the assigned team from Panchayat Samiti Mathili.
- 9- The Vendor offering best quality with lowest price will be considered for work order for the supply of items.
- 10- Being the authorized vendor, you have to submit the documents as an authorized vendor.
- 11- The quantity may vary as per the requirement.
- 12- This EOI may be cancelled at any time without any reason mentioned.
- 13- In case of any dispute, the decision of the Block Development Officer, Mathili is final
- 14- **The price quoted by the vender must be inclusive of all expenses/ price such as transportation cost, applicable GST etc.**
- 15- If any legal dispute arises, the Jurisdiction of the matter is limited /subjected within Malkangiri District only.


