Interested bidders can download the tender documents from the website and sealed tender paper should be dropped into the Tender Box meant for the purpose kept in the District Election Office, Malkangiri or submitted through Speed Post/ Registered Post along with security money (refundable) of Rs.10,000/-(Rupees Ten Thousand) only and Rs.500/-(Rupees five hundred) only towards cost of tender paper(Non-Refundable) in shape of Bank Draft/ bankers Cheque drawn in favour of Deputy Collector, Election, Collectorate, Malkangiri. The bidders participated earlier need not submit the cost of Tender paper and security money(EMD).

The DEO & Collector, **Malkangiri** reserves the right to accept or reject any or all the tenders without assigning any reason thereof and also issue Corrigendum/ addendum to the Tender Call Notice ,which will be published in the District Website/ Office Notice Board, if felt necessary. Terms and Conditions:

- 1) The bidder shall have to submit his bid under two bid system as "Technical Bid" and "Financial Bid". The technical bid envelop should contain all the required documents such as 1. Aadhar Card, 2. Valid PAN CARD, 3. GSTIN registration certificate, 4. GSTIN Return, 5. Income Tax clearance (preceding 3 years) 6. bank drafts towards EMD ,7. Cost of tender papers. The financial bid envelop should contain the rates of items quoted as per Annexure-A. Both the envelops should be marked separately as "Technical Bid" and " Financial Bid" and put in a large envelop marked as "Tender for CCVT". All envelops should be duly sealed.
- 2) All the pages of the tender papers should be signed with seal of the firms/ agencies.
- 3) Financial Bid will be accepted only in the prescribed form as Annexure-A
- 4) Bids received after due date will not be entertained and shall liable for rejection.
- 5) All the rates should be quoted including GST.
- 6) The Technical Bid shall be opened first. The financial bids of only technically qualified bidders shall be opened.
- 7) Any legal dispute arises out of this is subject to jurisdiction of Malkangiri only.
- 8) The tenderer should have not been blacklisted by any Government organization,
- 9) If found later on, action shall be initiated against the firm as per the law.
- 10) The District Election Officer & Collector, Malkangiri reserves the right to accept or reject any or all the quotations without assigning any reason thereof and also has the right to allot/ distribute the work to L2 firm at the Lowest (L 1) rate in case of LI bidder fails to deliver the services/installation of CCTV.
- 11) In case of breach of any terms and conditions and failure to supply the required videographers with video cameras by the successful bidder, the District Election Officer, Malkangiri will have the right to cancel the order/ contract without assigning any reason thereof and the security deposit of the bidders will be forfeited.
- 12) The earnest money/ security money shall be retained as performance security till the completion of contract.
- 13) TDS and GST shall be deducted at source as per applicable rates by the deductee (DDO).
- 14) Payment will be made within 15 days after receipt of the invoice/ bills.
