



3. Sealed Tender are invited from the registered firms/Press having the work experience of Photography, Videography and Live Streaming Services. **(Annexure- V & VI)**

5. The Bidders must be registered under Odisha GST (OGST) Act. & also having valid food license issued by appropriate authority of the Govt.
