The merit list shall be drawn upon the basis of weighted percentage of marks obtained in all the 06 categories mentioned in the table above. In case more than one candidate has equal marks, the candidate with past experience of working in child rights will be given preference. The decision of the selection committee in this regard shall be final.

The selection committee shall make and recommend the name of 05 candidates for each position if found suitable for appointment against the vacant positions. The candidates scoring the highest marks (top five) will be called for certificates verification of prior to issue of appointment order. The panel will be valid for 1 year from the date of finalization. Any joining or exit of employees shall be done with the prior approval of the District Magistrate and Collector. JOB TOR FOR THE STAFF WORKING IN CCI (OBSERVATION HOME & SPECIAL HOME) Duties of the House Father

- (i) 'Every house father or house mother shall abide by the direction of the person-incharge.
- (ii) The general duties fictions and responsibilities of a house father shall be as follows:
- (iii) Handle every child in the CCI (Observation Home & Special Home) with love and affection.
- (iv) Take proper care of the child and ensure his welfare:
- (v) Provide each child upon his reception with all necessary supplies like clothing, toiletries and such other items required for daily usage.
- (vi) Replenish the provisions or supplies as per scale and need of the child; Maintain discipline among the children,
- (vii) Ensure that the children maintain personal clean lines and hygiene:
- (viii) Look after maintenance, sanitation and maintain hygienic surroundings;
- (ix) Implement the daily routine of every child in an effective manner and ensure the participation of the children,

- (x) Look after safety and security arrangements in the CCI (Observation Home & Special Home).
- (xi) Escort the children whenever the go out of the CCI (Observation Home & Special Home) for purpose other the production before the Board the Committee or the Children's Court;
- (xii) Report to the person-in-charge and to the child welfare Officer about the child assigned to the child welfare officer.

(xiii) Maintain the registers, relevant to their duties.

Duties and Responsibilities of Art Craft and Music Teacher

The duties of the art, craft and activity teacher is conducting art and craft and other activities for the children in the children home which may be such as:

- Divide children in groups based on their age.
- Ensure that every child in the children home is allocated a group and receives a minimum of 2 sessions of 2 hour's duration in a week.
- Conduct sessions in a modular manner with a plan such that:
 - Children learn different styles of art- different periods and art forms, traditional art forms from around the county.
 - They learn history of art and stories of famous artists.
 - They get to participate in projects and are acknowledged for their work.
 - Provide positive feedback and reinforcement to the children through the sessions.
 - Design sessions in such a manner that children find a way to express themselves and also have conversations about themselves through the projects/paintings/craft items they prepare.
 - Use information available on the internet to help with research and development of modules.
 - Liaise with the Superintendent/Person-in-charge such that children who are interested are permitted to participate in government organized art competitions.
 - Under supervision and direction of the Superintendent/Person-in-charge work with volunteers to undertake art and craft projects with the children-e.g. Painting of murals, decorating walls of the institution.
 - Liaise with the Superintendent/Person-in-charge to get materials required for art projects donated/sponsored from the community, department, DCPU or corporate.

Duties and Responsibilities of P.ET Instructor

- The sports/ yoga teacher shall be available on fixed hours at fixed times daily and shall perform his duties under the supervision of Person-in- charge.
- She/he must ensure that each child participates in minimum 2 hours of group activities daily.
- The sports teacher shall under the supervise ion of the Superintendent/Person-incharge ensure that there is an adequate supply of sports equipment.
- The sports teacher shall train the children in sports and athletics.
- The sports teacher shall coordinate and organize volunteers:
 - Undertake training of children in different sports and athletics.
 - o Competitive matches and tournaments.
