OFFICE ORDER

Sub: Engagement of TGT PCM, TGT CBZ, Hindi & PET Guest Teachers against the vacancies of sanction post of teacher in Govt.(SSD) High Schools & Girls' High Schools.

The following merit candidates empanelled in the list duly approved by the District Level Selection Committee through walk in interview for hiring of guest teachers against the vacancies of sanctioned post of TGT PCM, TGT CBZ, Hindi & PET Guest Teachers in Govt.(SSD) High Schools & Girls' High Schools are hereby engaged as Guest Teacher and posted to Govt.(SSD) High Schools & Girls' High Schools in this district as mentioned against each until joining of a regular teacher. They are directed to join at their respective High Schools within 7 days from the receipt of this engagement order without fail. The honorarium of guest teacher is Rs.400/-Rupees(Four hundred) per class/ period and not exceeding Rs.16000/-Rupees(Sixteen Thousand) maximum 40 classes in a month in the following terms and conditions.


**Terms and Conditions:**

1. The Guest Teacher engaged would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of SSD Deptt.
2. Working hours and period of duration shall be as per the School time table.
3. The engagement of these Guest Teachers will automatically come to an end once a regular/contractual teacher appointed /engaged against the vacant post or as and when the appropriate authority decides.
4. The Guest Teacher so engaged shall also be entrusted with correction and evaluation work of the concerned subject in the school and he/she will not be entitled for extra honorarium for such work.
5. The performance of the teacher will be reviewed on regular basis. If any teacher is found to be nonperforming or engaged in activities leading to misconduct, he/she shall be disengaged.
6. The retired teacher engaged as Guest Teacher shall be disengaged on attaining the age of Sixty-five (65).
7. A Guest Teacher if in case is found remaining unauthorised absent and not taking classes for a continuous period of 15 days or more shall be deemed to be terminated and he/she shall never be entertained further.
