1. SCOPE OF WORK AND GENERAL INSTRUCTION FOR BIDDERS:

a. Scope of Work

PwBDs with "high support" means an intensive support, physical, psychological and otherwise, which may be required by a person with benchmark disability for daily activities, besides independent and informed decision, and to access facilities and participating in all areas of life including education, employment, family, community life, treatment and therapy.

People with severe disabilities are considered to have severe intellectual disability, autism, deaf blindness, and other multiple disabilities. They present great learning, behavioural, personal, social, physical, and sensory challenges and have extensive support needs (e.g., related service providers, health & rehabilitation professionals peers tutors). Additionally, a number of these individuals may have serious medical and health-care needs and be dependent on advance medical technology. Historically, those with severe disabilities have been some of the most devalued, persecuted, and marginalized people. With lack of learning and support needs, expectations for students and adults with severe disabilities are up to mark, as it was presumed that they had limited capacity to acquire, process, Utilisation of information and achieve a true level of independence or competency.

Severe disabilities refer to deficit in one or more areas of functioning that significantly limits an individual's performance of major life activities. The label of severe disabilities can include challenges in one or more of the areas: Cognition Communication Mobility/Gross Motor Skills Fine Motor Skills Self-help Skills Social/Emotional Skills, Adaptive Behaviour Hearing impairment /visual impairment, and finally Health impairment.

b. Objectives:

- a) To create an enabling environment with focus on encouraging voluntary action for ensuring expansion of institutional care for rehabilitation of Persons with Benchmark Disabilities requiring High Support need by creation of facilities for providing high- tech rehabilitation and care services.

- b) b) To set up & operate residential centre with 50 PwBDs requiring high support needs initially in each district preferably in IICs developed by the Department with facilities of comprehensive rehabilitation services with focus on PwBDs in critical conditions including homeless and destitute certified under high support needs
- c) c) To provide critical and comprehensive rehabilitation services and health care facilities to the inmates including treatment, therapies, counselling, assistive devices, Ply& recreation, ADL etc. as per requirement.
- d) d) To support inmates for basic literacy, skill training and centre-based employment in viable trades for promoting their independent living with facilities of forward and backward linkage for procurement and marketing of their products
- e) e) To provide facilities on moral and spiritual education, centre-based sports (both indoor& outdoor), recreation, Yoga and allied supports for ensuring a qualitative and healthy living.
- f) To Support inmates for their maintenance and nutritional diets, dress, footwear, and allied services essential for their survival and decent living.

2. Eligibility Criteria:

- a. Should be registered either under the Societies Registration Act, 1860 or the Indian Trusts Act, 1882 or Section 8 of the Companies Act, 2013 or any other appropriate Act as may be notified by the Government of Odisha from time to time
- b. Should be registered under Section 80G & 12AA of the Income tax Act, 1961.
- c. Should be registered under the NGO Darpan Portal of Government of India
- d. Should be registered under Section 50 of the Rights of Persons with Disabilities Act 2016
- e. Should be registered under Section 12 of the National Trust for the Welfare of Persons with Autism, Cerebral Palsy Mental Retardation and Multiple Disabilities Act, 1999.
- f. Should not have been blacklisted by any Central or State Government agencies
- g. Should ordinarily have existed for a period of Ten years and have resources, facilities and experience for undertaking the program.
- h. Five years' experience in providing similar services to Severe/ Profound Categories of Intellectually, Cerebral Palsy, Autism and Multiple Categories of Children/ Persons with Disabilities
- i. Should not discriminate against any person or group of persons on the grounds of sex, religion, caste, creed or disability; and
- j. The agency should be working in similar and allied fields with proficiency and understanding of different programmes. The agency should also have expertise and manpower in providing services.
- k. Should not have any track record of contract termination of the previous assignments or any adverse report of performance or blacklisted by any state Govt./ Central Govt. Organization.

3. PROGRAMME COMPONENTS

4. Operational Guidelines:

A detailed operational guideline for management of rehabilitation centre for Persons with Bench Mark Disabilities requiring high support need as received from the Government in SS&EPD Department is enclosed as Annexure for reference and follow-up.

5. Application Procedure:

- a. The interested Bidders may submit the EOI document complete in all respects and other requisite documents with a Demand Draft of Rs 1000/- (Rupees One Thousand) only as application fees in favour of District Social Security Officer Malkangiri on or before **11.12.2024 by 05.30 PM** & addressed to **District Social Security Officer, Collectorate, Malkangiri** (on behalf of Collector) by **registered Post/ Speed Post/ Courier**. The District Administration, Malkangiri shall not held responsible for any postal delay.
- b. The Authority may, at its discretion extend the dateline for submission of EOI by amending the EOI documents in which case all rights and obligation rest on the authority.
- c. **Late Bidders:** Any bid received by the authority after the prescribed time and dateline for submission of bids will not be considered. Thus, the same is deemed to be rejected.

6. Evaluation of BID & award of Contract

- a. The DLPAC Committee will evaluate the Bid and documents submitted by the agencies on **12.12.2024 by 05:30 PM**. Firstly, the document/papers asked in bid will be evaluated. There after the bidders will be called for presentation before the committee on the same day.
- b. **Presentation by shortlisted agencies:** The shortlisted agencies are required to present their case before Evaluation Committee on **12.12.2024 by 03:00PM**. Basing on presentations by agencies and other required documents and informations the Evaluation Committee will empanel the agency/agencies.

7. Approval of PIA:

The DLPAC shall submit the details of PIA/Agency selected at the district level for approval of Government.

8. Signing of Contract:

- a. The Appropriate Authority after receipt of Government approval will sign the contract agreement. The successful bidder/s whose bid has been accepted will sign an agreement with the concerned within 15 (fifteen) days of issue of the order and commence programmes and services within 30 (thirty) days from signing of contract agreement.
- b. Failure by the bidder to comply with the requirement of above-mentioned clause, the offer shall be rejected and the bidder shall have no claim further.
- c. The awardee shall have to fulfil the terms & conditions as laid down in EOI.

**Operational Guidelines on Management of Rehabilitation Centre for
Persons with Benchmark Disabilities Requiring**

Concept

Persons with disabilities comprise 16 per cent of the world's population, with 80 per cent of persons with disabilities living in the Global South. Women, children, and men with disabilities are frequently those mostly affected by natural hazards, climate-induced disasters and global health emergencies, like COVID-19 pandemic. Disability is a risk multiplier that cuts across identity characteristics and social determinants such as gender, age and socioeconomic status, and amplifies pre-existing social inequalities and power imbalances. Disability is diverse, and how exclusion is experienced varies, with many persons with disabilities, including persons with neuro-cognitive and psychosocial disabilities, further marginalized and underrepresented in decision making process.

Rights of Persons with Disabilities Act, 2016; National Trust for Welfare of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disability Act, 1999 and Mental Health Care Act, 2017 have mandated for creating adequate facility for rehabilitation of persons with benchmark disabilities.

1. Background:

Odisha is housing an estimated population of 4.80 Crore in 2023 and NSSO estimates 3.2% of the state's population i.e. approximately 16 lakh are estimated as Persons with Benchmark Disabilities (PwBDs), which is higher than the national average of 2.2%. Around 10% of the Persons with Benchmark Disabilities are categorized under severe and profound categories. Out of the PwBDs in these categories a majority are left to their fate as currently no Critical Care Support System is available. A number of such persons are either deserted or destitute to suffer the most and their disabilities are multiplied to their vulnerabilities .

Rights of Persons with Disabilities Act, 2016; National Trust for Welfare of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disability Act, 1999 and Mental Health Care Act, 2017 have mandated for creating facility for rehabilitation of persons with intellectual disabilities and mentally ill persons. Section 38 of Rights of Persons with Disabilities Act, 2016 followed by notifications on PwBDs with High Support Needs mandates for creation of special care facilities for those people.

2. Introduction

PwBDs with "high support" means an intensive support, physical, psychological and otherwise, which may be required by a person with benchmark disability for daily activities, besides independent and informed decision, and to access facilities and participating in all areas of life including education, employment, family, community life, treatment and therapy.

People with severe disabilities are considered to have severe intellectual disability, autism, deaf blindness, and other multiple disabilities. They present great learning, behavioral, personal, social, physical, and sensory challenges and have extensive support needs (e.g., related service providers, health & rehabilitation professionals, peers tutors). Additionally, a number of these individuals may have serious medical and

health-care needs and be dependent on advance medical technology. Historically, those with severe disabilities have been some of the most devalued, persecuted, and marginalized people. With lack of learning and support needs, expectations for students and adults with severe disabilities are up to mark, as it was presumed that they had limited capacity to acquire, process, Utilisation of information and achieve a true level of independence or competency.

3. Definition:

A Person with Benchmark Disability requiring High Support Need is defined under Section 2(r) of Rights of Persons with Disabilities Act, 2016 as "Person with Benchmark Disability" i.e. a person with not less than forty percent of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as assessed by Rehabilitation Professionals basing upon the scoring by Assessment Board for high support needs vide Notification No. 6145/ SSEPD dated 15th July 2023 with a score not less than 60 out of 100 points.

4. Objectives:

- a) To create an enabling environment with focus on encouraging voluntary action for ensuring expansion of institutional care for rehabilitation of Persons with Benchmark Disabilities requiring High Support need by creation of facilities for providing high-tech rehabilitation and care services.
- b) To set up & operate residential centre with 50 PwBDs requiring high support needs initially in each district preferably in IICs developed by the Department with facilities of comprehensive rehabilitation services with focus on PwBDs in critical conditions including homeless and destitute certified under high support needs.
- c) To provide critical and comprehensive rehabilitation services and health care facilities to the inmates including treatment, therapies, counseling, assistive devices, Ply & recreation, ADL etc. as per requirement.
- d) To support inmates for basic literacy, skill training and centre based employment in viable trades for promoting their independent living with facilities of forward and backward linkage for procurement and marketing of their products.
- e) To provide facilities on moral and spiritual education, centre based sports (both indoor & outdoor), recreation, Yoga and allied supports for ensuring a qualitative and healthy living.

- f) To support inmates for their maintenance and nutritional diets, dress, footwear and allied services essential for their survival and decent living.

5. Eligibility of PIAs:

Following organizations/ institutions shall be eligible for assistance under this scheme:

- 5.1 Should be registered either under the Societies Registration Act, 1860 or the Indian Trusts Act, 1882 or Section 8 of the Companies Act, 2013 or any other appropriate Act as may be notified by the Government of Odisha from time to time;
- 5.2 Should be registered under Section 80G & 12AA of the Income tax Act, 1961;
- 5.3 Should be registered under the NGO Darpan Portal of Government of India;
- 5.4 Should be registered under Section 50 of the Rights of Persons with Disabilities Act 2016.
- 5.5 Should be registered under Section 12 of the National Trust for the Welfare of Persons with Autism, Cerebral Palsy Mental Retardation and Multiple Disabilities Act, 1999;
- 5.6 Should ordinarily have existed for a period of Ten years and have resources, facilities and experience for undertaking the program.
- 5.7 Five year's experience in providing similar services to Severe/ Profound Categories of Intellectually, Cerebral Palsy, Autism and Multiple Categories of Children/ Persons with Disabilities
- 5.8 Should not discriminate against any person or group of persons on the grounds of sex, religion, caste, creed or disability; and
- 5.9 Should not have been blacklisted by any Central or State Government agencies.

6. Procedure of application

- 6.1 Eligible PIAs shall apply for grant-in-aid in prescribed form (Annexure -I) to the Collector concerned along with requisite documents.
- 6.2 The DSSO concerned shall inspect the organization, record his/ her findings and place the report before the Collector for recommendation of the proposal for consideration of GIA by SSEPD Department.
- 6.3 On receipt of the application, the Department will process the application and put before the Governing Body to consider for its approval and sanction thereof.
- 6.4 The decision of Governing Body will be communicated to the PIA under intimation to district administration.

7. Beneficiaries:

50 Persons with Benchmark Disabilities requiring High Support Needs as defined under RPwD Act 2016 required intensive support, physical, psychological and otherwise to take independent and informed decision to access facilities and participating in all areas of life including education, employment, family and community life, treatment and therapy in the age group of 6- 45 years assessed by the rehabilitation Professionals/ Health professionals basing upon the scoring by Assessment Board for high support needs vide Notification No. 6145/ SSEPD dated 15th July 2023 with a score not less than 60 out of 100 points will be enrolled in the centre. However, preferences will be given on the following disabilities:

- Severe and Profound ID & MD Children & Adolescents who are unable to perform activities of daily living (ADL) such as toilet control, bathing, eating, wearing dresses, communicating etc.
- Children/Adolescents ID & MD associated having problems such as cerebral palsy, delayed speech & language development, epileptic fits, lack of motor coordination, hyperactive behavioral problems etc.
- Children/ Adolescents with ID & MD having severe health hazards, destitution and other disabilities such as loss of hearing, vision, speech defect etc.
- Children & Adolescents with Autism, Developmental disabilities, Down's Syndrome, Emotional disturbance, Multiple sclerosis, Seizure disorders, Speech/language disorders, Spinal cord injury, Tourette Syndrome and Traumatic brain injury etc.
- Such other priority categories of PwBDs with high support needs, particularly neurological and cognitive disabilities; physical & sensory disabilities; homeless, destitute and deserted persons.

8. Facilities:

- Accommodation for 50 PwBDs with High Support Needs
- Nutritional diet
- Critical health, AYUSH & rehabilitative care
- Therapeutic services- physio - occupational therapy, speech therapy, psychotherapy
- Yoga & Yogic Therapies
- Special aids and appliances
- ADL training & independent living
- Clinical counseling and allied treatment & care services
- Special and basic education
- Training in sports, arts, crafts, painting, music (both vocal & instrumental),
- Skill upgradation training (both pre- vocational & vocational)
- Guidance & counselling to inmates, parents
- Such other services as may be required

9. Basic Services:

I. Diagnostics

- a) Diagnostic tools for the assessment of intelligence, behavioral disorders and communication disorders as well as problem specific approved tools like ISAA tools for Autism should be available at the centre. The affected person may have more than one disorder (i.e. simultaneously ADHD & Learning Disability, Autism & ID etc. Cerebral Palsy with Seizure Disorder).
- b) Diagnostic tools for assessment of mental illness, physical examination, lab tests and psychological evaluation (IDEA test).
- c) Registration of all PwD beneficiaries under UDID portal and certification thereof.

II. Therapeutics

- a) Mainstream therapies include Speech Language Therapy, Physiotherapy, Occupational Therapy, Psychotherapy - Behavioral Modification, Special Education, Audio logical Rehabilitation.
- b) Suggested alternate therapies include Play Therapy, Music Therapy, Art and Craft Therapy, Hydro Therapy, Social Integration Therapy.
- c) The Traditional remedies include Yoga, Pranayama and Ayurvedic treatment. The dietary intervention plays an important role in many of these children.
- d) Most of the professional therapies may be done on one-to-one basis except for special Education and alternate therapies.

III. Counseling & Psychotherapy

- a) Counseling is the helping approach that highlights the emotional and intellectual experience of a client, how a client is feeling and what they think about the problem they have sought help for.
- b) Psychotherapy is based in the psychodynamic approach—it encourages the client to go back to their earlier experiences and explore how these experiences affect their current 'problem'.

IV. Skill training

- a) Skill training for the adult PwDs for acquiring vocational skills that would help the PwDs to earn employment or self-employment in suitable and viable trades.
- b) Pre-vocational training to PwDs in the age group of 14-18 years after assessment of skill interest and capacity.

V. Referral & Follow-up

- a) Referral of cases for different services including education, linkage for pension, self-employment assistance and other support services.
- b) Follow-up on post discharge status of PwDs and community visits to ensure better environment for the PwD beneficiaries at family and community settings.
- c) Home based therapeutic management and guidance for the severe & profound PwDs wherever essential.

10. Professional Manpower:

- Physiotherapist -01
- Occupational Therapist – 01
- Speech Therapist – 1
- Clinical Psychologist - 1
- Special Teacher (ASD, ID & HI)-03

- Cook & Helper - 02
- Admn. /Support Staff – 3
- Yoga Teacher – 01 (Part time)
- PET Teacher – 01 (Part Time)
- Night supervisor for Critical Care- 02
- Doctor – 01 (Part time)
- Security- 06nos. (02 persons for 03Shift)

11. Infrastructure & Equipment:

The physical infrastructure should be having dedicated space for the professional intervention like Physiotherapy, Speech Therapy, Occupational Therapy and the range of alternate therapies and traditional remedies.

Preference will be given for setting up of these centres in the IIC campus of the district. SSEPD Deptt. will provide space and building as per availability. If there is non-availability of IIC in the district than PIA should ensure availability of adequate space & building for the centre and rent paid for the premises will be reimbursed.

For Therapeutic services infrastructure should include electro therapy and exercise therapy equipment, Sensory integration, Motor integration, Vestibular stimulation Gadgets, Speech Language Therapy materials which includes Vernacular Languages.

List of the Tools to be used in the Therapeutic Center:

12. Records & Registers:

- d) Accounts Records (Cash Book & Ledgers, Remuneration payment/Acquaintance Register, Voucher Register, Stock and Store Register, Bank Account etc.)
- e) Other records (Meeting Resolutions Register, Parent counseling register, Progress Report file, and such other records prescribed)

13. Duties of the PIA:

The management of the project/ programme shall:

- a) Create minimum required infrastructure to set up the centre i.e. furniture, fixture, equipment and other physical facilities as may be required for operation of the project activities.
- b) Recruit and engage qualified staff required for operating services for the targeted beneficiaries.
- c) Comply with the conditions of grant-in-aid including submission of reports, utilization certificates and such other requirements.

14. Grant-in-Aid:

- a) The institutions will be released grant-in-aid at the rate as approved by the Government from time to time for continuance of the Centres.
- b) The grant-in-aid is inclusive of all expenses of the centre including staff remuneration, nutrition, contingencies and such other incidental expenses as may be required as detailed hereunder.
- c) The first installment (50%) of grant-in-aid will be released to the managing institution under intimation to concerned district collector after approval & sanction of the

project and submission/uploading of all beneficiary information with Aadhaar numbers.

- d) The second installment (50%) will be released during October to the managing institution under intimation to concerned district collector after receipt of (a) Utilization Certificate for first six months, (b) inspection reports form the District Social Security Officer, (c) Submission of half-yearly progress report, and (d) Updation of beneficiary status with Aadhaar details.

- a) The Centres will be monitored by the Social Security & Empowerment of Persons with Disabilities Department, Government of Odisha through DSSOs.
- b) The DSSOs shall ensure that list of beneficiaries, with necessary particulars, are maintained properly and category-wise in respect of their districts concerned.

19. Litigations

Any litigation on matters arising out of this scheme will be subject to the sole jurisdiction of the courts situated in Bhubaneswar.

20. Change in Scheme Provisions

Social Security & Empowerment of Persons with Disabilities Department, Government of Odisha may, at its discretion, make necessary changes in the provisions of this scheme, as and when felt necessary, with the approval of Principal Secretary of that Department in consultation with the Financial Adviser concerned.

21. Review of Scheme

Social Security & Empowerment of Persons with Disabilities Department, Government of Odisha may, at its discretion, undertake a review of the scheme as and when required.
