





**TERMS, CONDITIONS & SPECIFICATIONS FOR SUPPLY OF GAZELLE HB VARINT TEST MULTIPACK UNDER CDM&PHO, MALKANGIRI, FOR A PERIOD OF ONE YEAR.**

1. The bidders will download the tender from the District Web Site: <https://malkangiri.odisha.gov.in> and EMD Cost. Rs.1,00,000/- (Rupees One Lakh Only) in shape of Demand Draft in favor of "ZSS MISCELLANOUS MALKANGIRI"
2. The tender paper will be rejected if the bidder changes any clause or Annexure of the bid documents downloaded from the website.
3. Sealed tenders must be received on or before 20.02.2025 till 04:00 PM. Any tender document received after the due date and time will be rejected/returned to the sender unopened. The tender paper must be received through Speed Post/ Regd. Post only. The Sealed tenders will be open on dated 21.02.2025 at 11.00 AM in the presence of Purchase Committee Members and bidders/their authorized representative.
4. The CDM&PHO, Malkangiri shall have no responsibility for any delay / Omission on part of the bidder and reserves the right to reject any or all the tenders without assigning any reason thereof.
5. The bidder(s) are to submit their tenders in separate sealed covered envelopes for Technical Bid and Financial Bid by superscripting Cover 'A' (Technical Bid) and Cover 'B' (Financial Bid) & both the sealed covers should be put into a third outer cover which should be superscripted as "Tender for Supply of Gazelle HB Variant Test Multi pack for the year 2024-25" and Tender Reference No. -----/ Malkangiri.
6. The sealed tenders will be opened by the CDM&PHO, Malkangiri in the Office Chamber of , O/o- CDM&PHO, Malkangiri on dated 21.02.2025 at 11.00 AM. The bidder or their duly authorized representatives are allowed to be present during the opening of the tenders if they desire.
7. The rate quoted by the bidder should be inclusive of all taxes (GST/ET/Freight/insurance etc.).
8. Conditional tenders are liable to be rejected. All Disputes are subjected to District Court, Malkangiri, Odisha.
9. Bidders should submit the valid drug license/Challan Copy of renewal of Drug license photocopy (self-attested) from the Drug Controller.
10. Bidders will have to submit Valid ISO Certificate (ISO 9001:2015 & ISO14001:2015).
11. If the successful bidder/ bidders fail to supply within the stipulated period i.e. 30 (Thirty) days from date of receipt of order from CDM&PHO, Malkangiri, liquidated damage @0.5% the tender value per week of delay shall be deducted from the final payment. The maximum delay time acceptable is 6 weeks. Hence, the maximum liquidated damage shall be up to 4% of purchase order. If the bidder fails to supply within the maximum delay time his order stands cancelled automatically.

12. The Authority will not make any advance payment to the organization. The organization will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in that regards.
13. The cost towards the testing of sample will be borne by the successful bidder 2% of purchase order.
14. The items should be delivered by the approved bidder within 15 days of placing the order by the CDM & PHO, Malkangiri and the bidder shall submit the bill for payment as per the approved rate in respect to quantity of items supplied. The transportation of items is sole responsibility of the approved bidder and must deliver the items on destination delivery basis.
15. In case of failure on the part of the approved bidder to supply of the required items as per supply order within stipulated period, the CDM&PHO, Malkangiri shall be at liberty to purchase the required items from open sources and the approved bidder shall be liable to pay the excess amount which this office have to incur being the difference of actual amount of purchase minus the amount as per approved rates and difference aforesaid shall be recoverable and adjustable against the security deposit amount.
16. Under no circumstances shall the organization appoint any subcontractor or sublease the contract. If it is found that the organization has violated these conditions the contract will be terminated forthwith without any notice and security deposited by the organization shall be forfeited.
17. Rates quoted against this tender notice shall remain valid up to 12 months after the award of contract. No request for an increase in rates, if any, will be allowed or entertained during this period.
18. Bidders should submit the photocopy of valid GST Registration Certificate & PAN Card.
19. Receiving & Opening of Tender may be changed if required by the under Signed, it will be intimated.
20. The bidder should have experience in the supply of the same & similar items to Govt. / Pvt. Organizations during the last three years. The bidder has to furnish the work order/ contract copies in support of that.
21. The bidder has to submit the Performance / Experience Certificate of at least Two Years regarding Supply to the Govt. or Non-Govt. Health Facilities.
22. The bidder has to submit Manufacturer Authorization Certificate in original for the said tender
23. The Bidder has to submit ISO 9001:2015 Certificate.
24. The bidder has to submit affidavit in Non-Judicial Stamp Paper with appropriate value (i.e Rs.20/-) that his or her agency has not been blacklisted by any Govt./PSU organization.
