No tender paper will be sold by the Block Office, Korukonda or any other offices. 
Para No 2. Date of receipt of Tender Paper: Tender Paper complete in shape must be reached from **dt.17.03.2025 to 29.03.2025 (up to 5.00 pm)** in office hour(working days only) in the office of the Block Development Officer, Korukonda through **REGISTERED POST/SPEED POST** only. Tender received by post after stipulated date & time mentioned above will not be considered. Further no tender papers will be received by hand or by Courier Service. The undersigned will not be responsible for postal delay.

Para No 3. Date of Opening of Tender Papers: The tender shall be opened on **dt.02.04.2025** at **11-00 A.M.** in the office of the Block Development Officer, Korukonda in presence of the bidders or their authorized representatives having written authorization for the purpose along with all relevant original documents. In Case any Bidder or authorized representative is absent, then tender paper shall be opened without waiting for anyone.

Documents to be Attached : The following documents should be furnished with the Tender Papers failing which the tender is liable for rejection.

- a. Earnest money deposit pledged in favour of Block Development Officer, Korukonda.
- b. Self attested copy of valid Contractor Registration Certificate.
- c. Self attested copy of valid PAN Card and GST Registration certificates along with up to date GST return filling document.
- d. The bidders have to produce an original affidavit in support of the authenticity of documents including EMD attached with the tender paper,
- e. The Engineer Contractors desirous of availing exemption of EMD should submit an original affidavit as regards the fact of availing award of work without submission of EMD/ISD during the current financial year, otherwise their tender paper will be liable for rejection.
- f. The SC/ST contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate; otherwise their tender will be liable for rejection.
- g. Joint venture consortium agreements are not allowed to participate in tender.
- h. A critical analysis and working procedure should be submitted along with bid paper if the quoted amount is less than the estimate cost by more than 10% for examination by the committee.




i. The name of the project for which tender paper is filled should be written on the cover in which all the required papers are kept and sealed.






