



SHORT QUOTATION CALL NOTICE

Sealed tenders are invited from reputed and experienced agencies for Design, and Execution of a Children's Park with the items listed below, including provisions for specially-abled children, in Ecopark, Dhanurjayguda of Malkangiri Forest Division.

List of Items:

- HDPE Slide: 1 Unit
- Spring Riders: 2 Units
- Merry-Go-Rounds: 2 Units

Scope of Work:

- Design and execute a children-friendly park with the above items and enhancement of physical and cognitive abilities.
- Integrating existing structures into the new establishment.
- Implement measures to discourage adults from using children's facilities.
- Supply, installation of play equipment, seating, and safety features.
- Ensure environment-friendly and durable construction materials are used. All equipment will be made from High-Density Polyethylene (HDPE) or Fibre-Reinforced Plastic (FRP), known for their durability, safety and low maintenance requirements. The equipment will comply with international safety standards, including (i) ASTM F1487 (Standard Consumer Safety Performance Specification for playground equipment for public use) (ii) EN 1176 (European Standard for playground equipment).
- Each component must have a specified warranty period and a regular maintenance manual for each component must be supplied.

Eligibility Criteria:

- The bidder must have prior experience in designing and executing parks/playgrounds.
- Must have valid GST registration, PAN, and necessary clearances.
- Financial capability to execute the project within the stipulated timeline.
- Customer Satisfaction Certificate.

Evaluation Criteria:

- The tender evaluation will be based on 60% weightage for the technical bid and 40% for the financial bid.
- Previous Customer Satisfaction Certificate (Original) is highly essential for technical bid evaluation.
- During technical evaluation- GST, IT Returns, Previous work shall be given positively.
- Undertaking that the items supplied are ASTM F1487 / EN 1176 Standards with warranty of each structure.

Submission Details:

- The completed bid should be submitted in a sealed envelope on or before 19.03.2025.
- The envelope should be superscribed as "Tender for Children's Park at Ecopark, Dhanurjayguda".
- Notary certification for safety regulations for children's park and warranty.
- Successful bidders shall deposit a 5% security deposit and must enter into an agreement with the Ecopark, Chittrakonda Management Committee (VSS).
- The security deposit will be returned after three years.
- Bids will be opened on dated 19.03.2025.

Terms & Conditions:

- The lowest or any tender committee of the bid may not necessarily be accepted.
- The decision of the Divisional Forest Officer, Malkangiri, will be final.
- Any disputes arising shall be subject to jurisdiction in Malkangiri courts.
