The detailed terms & conditions of the bid are as under;

SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS

1. Eligibility Criteria:

The firms / agencies must have:

- (a) Registration Certificate of Manufacturers/Dealers/Suppliers & credible firms/ agencies
- (b) Valid PAN
- (c) Valid GST Registration under Odisha GST (OGST) Act.
- (d) Income Tax Return of last three years i.e. 2021-22, 2022-23 & 2023-24

2. Application Procedure:

- (a) The Bid has been invited under two bid system i.e. **Technical Bid and Financial Bid**. The interested bidders are advised to submit two separate sealed envelopes super scribed "Technical Bid for Procurement of Teaching Learning Materials" & "Financial Bid for Procurement of Teaching Learning Materials". Both sealed envelopes should be kept in another sealed envelope super scribed "Tender for Procurement of Teaching Learning Materials".
- (b) **Technical Bid & Financial Bid.**
The Bidder has to fill up the Technical bid Form (**Tech-1, Tech-2, Tech-3, and Tech-04**) & submit it with a separate envelope with all self-attested documents / papers as mentioned in para-2 (f). Similarly, the Financial Bid form has to be filled up as per prescribed form (**Fin-1 & Fin-2**) and to be submitted in separate sealed envelope. The bidder is to quote the rate in the prescribed format (**FIN-2**). The rate **per set** shall include GST, all other Tax, transportation cost & delivery of the complete material at block point. - (b) **Late Bids:** Any bid received by the authority after the prescribed time and dateline for submission of bids will not be considered and opened. Thus the same is deemed to be rejected.
- (c) The Technical bids shall be opened **on 23.05.2025 at 10.00 AM** at **Collectorate, Malkangiri, Odisha** in presence of the representatives of the bidders, if any, who wish to be present on the spot at that time.
- (d) Bidders/Firms shall supply one set of sample of each category (Set-1 & Set-2) after technical evaluation to the Tender Inviting Authority for sample verification by the District Level Committee. 6. Evaluation of BID:

- (a) The District Level Committee of the District Project Office will evaluate the Technical & Financial BID. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be opened.
- (b) The sample materials will be verified by the District Level Committee before opening of the financial bid. If the quality of the sample supplied by the bidder is found to be sub-standard then the bid of the bidder shall be rejected and financial bid of that bidder shall not be opened.
- (c) After satisfactory sample verification of technically qualified bidders, their financial bids shall be opened.

7. Acceptance or Rejection of the Bids:

- (a) The TIA reserves the right to accept / reject any / all bids / cancel the entire selection process at any stage without assigning any reason thereof. No claim, whatsoever, shall be admissible for the alleged loss / damage suffered by the bidder/s on account of such rejections.
- (b) Any bid with incomplete information is liable for rejection.

8. Award of Contract :

The contract will be awarded to the Bidder/s substantially responsive to the Bid document & offered lowest evaluated cost.

9. Signing of Contract :

- (a) The successful bidder/s whose bid has been accepted will sign an agreement with the TIA within 02 days of issue of the work order.
- (b) Failure by the tenderer to comply with the requirement of above mentioned clause, the offer shall be rejected and the tenderer shall have no claim further.

10. Performance Security Deposit:

The selected bidder shall have to submit Performance Security Deposit of 04% of contract value in shape of bank draft drawn on any Nationalized / Scheduled Bank in favour of the "Collector-cum-Chairman & DPC, SSA, Malkangiri, payable at Malkangiri only within 02 days from issue of the work order.

11. Requirement & Delivery Schedule :

The selected firm/Agency shall supply the Teaching Learning Materials within **20** days from the date of issue of the order. Approximately **39,425 nos. of Teaching Learning Materials Set are required for the students from Shishu Vatika to Grade-III**. The above requirement may increase or decrease as per need. The total cost will be decided on the basis of actual nos. of set supplied.

12. Payment terms:

- (i) **On completion of delivery at Block point:** Payment will be made after receipt of the required materials as under:
 - a. Challans towards satisfactory completion on supply of quantity to concerned block point as per supply order and quality of materials approved by the Committee.
 - b. Receipt of "receive in good condition & stock entry certificate" from concerned BEO.
 - c. On fulfillment of conditions of the agreement.
 - d. Four self-inking carbon copies of the GSTIN invoice as well as bank details for payment purpose.
- (ii) No advance payment shall be made, or no payment shall be entertained on negotiation through Bank.
- (iii) Deduction of tax at source shall be made at the appropriate rate as per prevailing law.

13. Penalty:

- (a) If the work is delayed for any reason for which the TIA is not responsible, penalty @ 0.5 % per day on the total cost maximum up to 10% of the contract value will be imposed on the firm under orders of appropriate Authority. The TIA reserves the right to forfeit the Performance Security & debar the bidder from participating in any other bid of his/her office. In such cases the TIA may write Govt. for blacklisting the firm.
- (b) If the quality of materials is found to be dissatisfactory, penalty as suggested by the District Level committee will be imposed. The bidder must ensure that supplied materials are same as the sample supplied during evaluation of the bid.

14. Amendments to BID terms, conditions and issue of Corrigendum / addendum:

- (a) Seven (07) days before the last date of submission of Bids, the TIA may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder/s, modify the Bidding Documents by amendment / corrigendum.
- (b) The amendment in shape of corrigendum/addendum will be notified on the websites <http://malkangiri.odisha.gov.in> & www.osepa.odisha.gov.in and the prospective bidder/s are requested to take cognizance of such notification/s while submitting their tender proposal.
- (c) In order to allow prospective Bidder/s reasonable time in which to take the amendment into account in preparing their bid, the TIA may, at its discretion, extend the deadline for the submission of bids.

15. Only one tender should be submitted by one party. Submission of more than one tender will lead to rejection of all proposal of the bidder.
16. All the information uploaded & submitted or supplied in the formats of this tender document shall be presumed to be true to the best of the knowledge of the bidder/s.
17. No document as required and mentioned in the Bid shall be submitted in the Technical bid / Financial bid documents unless otherwise specifically mentioned therein. All required documents shall be uploaded with serial number and page mark.

19. The bid validity period is 90 days from the date of opening of the Financial bid. Accordingly the bidder shall submit the Bid.
20. The TIA reserves the right to reject any or all the bids without assigning any reason thereof. The TIA also reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.

21. Resolution of Disputes:

- (a) Any dispute between the Tender Inviting Authority (TIA) and the successful bidder/s should be addressed to the other party only in writing in their respective letter heads signed only by the designated signatories as in contract agreement. Both the parties shall make every effort to resolve the same amicably by mutual consultations.
- (b) If both the parties fail to resolve their dispute or difference by such mutual consultation within twenty-one days of its occurrence, the same will be referred to by either party for conciliation to the conciliation panel. For that purpose, both the parties, shall nominate each one member, and both the nominated members shall form the Conciliation panel. In case the panel members report failure of conciliation, the matter shall be referred to arbitration, by the Arbitrator, to be nominated by the Collector cum Chairman, Samagra Shiksha, Malkangiri. The Collector cum Chairman, SS, Malkangiri shall nominate an Arbitrator, whenever required or when a request is made by the successful bidder/s, after the failure of conciliation, to nominate an Arbitrator. The arbitration proceeding shall be as per the provisions of the Arbitration and Conciliation Act 1996 of India.

22. Applicable Law and Jurisdiction of Courts:

- (a) The Contract shall be governed by and interpreted in accordance with the existing law of India in force.
- (b) All disputes relating to the contract is subject to the pecuniary jurisdiction of the Court at Malkangiri.
