✚ Back ground

Odisha Adarsha Vidyalaya Sangathan is a path breaking initiative of Govt. of Odisha to provide quality teaching in English medium at Secondary and Higher/Senior Secondary level for the children specially in semi-urban or rural areas and to give scope to rural talents who are unable to afford English medium education. Originally, a new scheme "Model Schools" was launched by Govt. of India under central assistance scheme to provide a good quality English Medium scheme as par with Kendriya Vidyalaya in all Educationally Backward Blocks of the state. Subsequently, the scheme has been delinked from central assistance from the financial year 2015-16. After de-linking of the scheme, state Govt. has decided to implement the scheme and establish one Odisha Adarsha Vidyalaya in all 314 blocks of the state phase wise.

Basically Odisha Adarsha Vidyalayas have infrastructure and facilities of the same standard in Kendriya Vidyalaya with stipulation on Pupil-Teacher ratio, ICT usages, holistic educational environment, appropriate curriculum and emphasis on output and outcome. The objective is to provide high quality English medium school to the rural talents. The NEP has been implemented as per the instruction of CBSE & OAVS.

Key features of Odisha Adarsha Vidyalaya:

- The objective is to provide high quality English medium school to the rural talents.
- Vidyalaya will have holistic and integral touching upon physical, aesthetic development in addition to academic.
- There are 32 rooms in ground floor and 32 rooms in 1st floor including 18 class rooms and other facilities.
- The Vidyalaya will have adequate ICT infrastructure and internet connectivity.
- There will be sufficient scope for sports and co-curricular activities.
- There is provision of Art, Music and Computer Teacher besides subject teachers.
- Special emphasis will be given on teaching of Science, Math and English.
- There is provision of well equipped laboratories and library.
- Medium of instruction is English and the Vidyalayas will be affiliated to CBSE.
- The Vidyalayas will have appropriate pace setting activities, so that Vidyalayas in the neighborhood can benefit from it.
- The classes will be from VI to XII having two (02) sections in each class with intake capacity of 40 in each section.
- The reservation of seats for students will be as per the percentage of SC & ST population in the respective Blocks.
- There is also 50% reservation for Girls.
- All efforts will be made to make it really a centre of excellence.

GUIDELINES FOR ADMISSION OF STUDENTS IN CLASS XI(SCIENCE) IN
OAV CHITRAKONDA, 2025 - 26

1. Intake Capacity

Science 80 (02 Sections with 40 Students)

2. Subject Combination

For Science

- i. Physics, Chemistry, Mathematics, Biology, English
- ii. Physical Education/ Painting/ Information Technology/ Artificial intelligence are to be offered as elective/ 6th optional subject following CBSE guideline and any other instruction issued by OAVS.

3. Minimum Eligibility

CLASS XI (SCIENCE)

i. A student belonging to the **General/OBC/SEBC** must have secured **55% or above marks in aggregate** along with **minimum 50% marks in both Mathematics and Science (combined)** in Class X board examination.

ii. A student belonging to the **SC/ST** category must have secured **50% or above marks in aggregate** along with **minimum 45% marks in both Mathematics and Science (combined)** in Class X board examination.

4. A Student shall apply for admission in one stream only.

5. All notifications and circulars issued by CBSE shall be followed for subject combination in Class XI as per stipulated guidelines.

6. Order of preference for admission:

- a. Students of own OAV (Including students selected for (Iconic OAV)
- b. Students of other OAVs (of same district, not having Class XI) selected for Iconic OAV
- c. Students of other OAVs (of same district, not having Class XI)
- d. Students of other OAVs (of same district, having Class XI)
- e. OAV students of other districts
- f. Students of Government/ Government aided High schools within the same block.
- g. Students of private high schools within the same block.
- h. Students of Government/ Government aided high schools of other blocks of the district.
- i. Students of Private high schools of other blocks of the district.
- j. Students of Government/ Government aided High schools of other district.
- k. Students of private high schools of other district.
- l. Students of other states

7. Student selected for Iconic OAV, Bhubaneswar is eligible for taking admission in Science stream only.

8. Merit list shall be prepared on the basis of merit i.e. the marks secured in Class X board examination (CBSE or any other board) as detailed in point 3 above.
