ADDENDUM /CORREGENDUM

In continuation of Tender call Notice No- 01/2025-26 published vide this office Letter No 2099 dated 10.07.2025 the following modifications have been made as under.

1.	Engineer Contractor desirous to avail the facility of exemption of E.M.D is required to submit an affidavit (Original) to the effect that he has not yet been awarded more than two works (Excluding this work) with exemption of E.M.D during the current financial year. The name of the works awarded with exemption of E.M.D and the tender inviting authority must be mentioned in the affidavit, failing which the bid shall be rejected.	Engineer Contractor" desirous to avail the facility of exemption of E.M.D should abide by the norms as contained in No. FA-Codes/6/2011-600W dtd. 18.01.2011 as furnished in DTCN & is required to submit an affidavit (Original) to the effect that he has not yet availed the facility / participated in the tender for more than two works (Excluding this work) during the current financial year. The name of work for which participated and the authority to whom the tender was submitted must be mentioned in the affidavit, failing which the tender will be rejected. Also he should submit the original engineering license at the time of opening of tender for recording of exemption of EMD with due verification of previous exemption, availed if any. Affidavit must clearly mention that facility of exemption of EMD has not been availed for more than two works in the current financial year, failing which the bid shall be rejected.
2.	The last date of Receipt of Tender paper is 31/07/2025 up to 5.30 PM. The Tender paper shall be opened on 01/08/2025 at 11.00 A.M.	The last date of Receipt of Tender paper was 25/07/2025 up to 5.30 PM. The last date of opening Tender Paper was 28/07/2025 at 11.00 A.M.


