Observation Home and Special Home(OH&SH),Malkangiri invites offer in two parts (Technical and Financial) from interested chartered accountant firms. The Chartered Accountant firms should submit their offer in the prescribed format (Annexure/Sub- Annexure) of this tender.

01. Scope of Work

Conducting audit books of accounts and ancillary records and submit report on yearly basis 2023-24 to 2025-26

Detailed Activities of the service mentioned in scope of work are as follows

- a) The firm shall make 100% verification of vouchers, Head of Account wise entries of Receipt and Expenditure in Cash Book /Other Financial Statement, bills and books of accounts.
- b) Verification of the correctness of Trial Balance and Compiling the grouping statements and schedule to the annual Financial Statement also Receipt and Payment, Income and Expenditure and Balance sheet .
- c) Preparation of Bank reconciliation statement.
- d) Verification of Fixed Asset Stock register (Stock and Store).
- e) Audit of Procurement/tendering process of Fixed asset , Consumable , Stationary etc.
- f) Compliance of statutory obligation.
- g) Checking of Grants received and its utilization as per the terms of Grant.
- h) Verify the advances payment and and its settlement.
- i) Tours and Travel- adherence to OGFR travelling rules.
- j) Providing suggestions of improvement of the existing system of internal control.
- k) The firm shall ensure arithmetic accuracy of all entries and ensure that all transaction should recorded in subsidy book is reflected in the main cash book.
- l) Prepare of monthly analysis of opening and closing balance taking unadjusted advance given to different categories of employee.
- m) Reconciliation/Compilation of all bank accounts and ledgers like Stock & Store,GIA Register, Demand collection Register etc. Are prescribed under OGP Act.
- n) Ensure all financial transaction are recorded in Cash Book & reflected in Pass Book as well any variation found thereon is to be reported to the concerned authority/Institution immediately
- o) The CA Firm/Member of the Firm shall be visit at least two times in a month.
- p) Any other segment,besides above as advised by authority of DCPU,Malkangiri.

02. TIME PERIOD OF ENGAGEMENT

The selected Chartered Accountant firm will be required to provide the above mentioned service initially for F.Y 2025-26 which may be renewed for another two years on satisfactory completion of assigned work, notwithstanding anything contained herein above the agency, However reserves the right to discontinue the services of the Chartered Accountant firm at any time during the period of serving one week notice.

AUDIT COST

Audit Charges should not exceed Rs 5000/- (Rupees Five thousand Only) per Financial Year.

REPORTING

The Firm will submit its report to District Child Protection Officer, Malkangiri.

GENERAL

The Firm will be given to access to all information relevant for the purpose of conducting the audit. This would normally include all documents, correspondence, and other information associated with OH&SH, Malkangiri in addition to the Audit report and the annual Financial statement the firm should submit on audit observation.

03. PRE -QUALIFICATION OF THE CA FIRM

- A) The bids of only those firms will be considered, which satisfy the following eligibility criteria .
The Chartered Accountant Firm should submit authenticated document of the Following
- ◆ Copy of partnership deed
 - ◆ Copy of Last 03 three year Balance Sheet (I.e Profit & Loss A/c)
 - ◆ Copy of Last 3 Years IT return.
 - ◆ Registered with the Institute of Chartered Accountant of India (ICAI) and have Income Tax Permanent Account Number (PAN) and service Tax Registration.
 - ◆ The CA Firm should have been empanel with C & AG in the year for which they are to be engaged.
 - ◆ The turn over of the firm must be 3 times of the approximate contract value (The Value is to fixed by the concerned committee)
 - ◆ Have at least 2 partners . single proprietorship firms are not eligible to participate in the bid.
 - ◆ Have minimum 03 nos of other Audit staff in addition to the partners.
 - ◆ Not have been blacklisted by any Government or any other organization. Authorized Signatory(s) of the firm to submit an undertaking to this effect.
 - ◆ Submit relevant document duly attested by the authorized signatory in support of the eligibility criteria given above.
 - ◆ An undertaking to the effect that no person of the firm/partner is related to any employee of the concerned authorities/Institutions and success story, if any in streaming financial management through their assigned work .
- B) The audit team conduct for audit of OH&SH, Malkangiri must comprise of one audit manager and two audit staff .
The Audit Manager must be a CA qualified at least 03 years of post qualification experience
The Audit staff must have 03 years of audit experience in similar nature of work.

04. PAYMENT TERMS

The Payment against the service provided by the firm is subject to the following terms and conditions

- a) The price quoted by the Firm should be valid for the entire contract period payment shall be made at agreed rates. No price variation would be allowed during the contract period

- iv. The technical bid should not contain any indication of price offered, else the entire bid will be rejected
