Advertisement for Expression of Interest (Eoi) for organizing KRUSH RATHA-2025-26  
in Malkangiri District

Expression of Interest (Eoi) is invited from the intending firms/supplier having GSTIN registered for the State of Odisha for organising of Krushi Ratha programme 2025-26. The Rath should cover all GPs/Headquarters for 5 days in each Block with well decorated & proper sound system to create awareness through specified content & critical messages vetted by Agriculture Department by way of folk dance/drama/pala that could able to create awareness among the farmers with following conditions.

01. The agency must have valid PAN number and GST registration with up to date income tax and GST clearance certificate.
02. The agency should not be black listed
03. Preference would be given to the agency who have past experience for similar assignments in Agriculture Department in Malkangiri district.
04. The vehicle must be in a road worth condition and shall not be more than 3 years old from the date of initial registration with valid RC Insurance certificate, Fitness certificate etc. and other valid documents which are mandatory for plying of vehicle.
05. Driver of vehicle must have valid driving licence for driving
06. The vehicle should cover each GP headquarter of 7 blocks of the District mandatorily.
07. Successful completion certificate to be obtained from the concerned BAO of the Block while submitting the final output.
