2. Date of receipt of Tender Paper: Tender Paper complete in all respect must reach from **dt.06.12.2025 to 22.12.2025 (Up to 5.30 PM)** in office hour (working days only) in the office of the Block Development Officer, Korukonda through **REGISTERED POST/ SPEED POST** only. Tender received by post after stipulated date & time mentioned above will not be considered. Further no tender papers will be received by hand or by Courier Service or any other means. The undersigned will not be responsible for postal delay.

3. **Date of Opening of Tender Papers:** The tender shall be opened on date. **23.12.2025** at **11-00 A.M.** in the office of the Block Development Officer, Korukonda in presence of the bidders or their authorized representatives having written authorization for the purpose along with all relevant original documents. In Case any Bidder or authorized representative is absent, then tender paper shall be opened without waiting for anyone.

4. **Cost of Tender Paper :** Cost of tender paper will be **Rs.6000/-** for all the works. Cost of tender paper in shape of **Demand Draft** drawn in any Nationalized Banks /Schedule Banks in favour of the Block Development Officer, Korukonda payable at **Malkangiri** has to be submitted along with tender documents. Bids received without above cost or with inadequate tender paper cost shall be liable to get rejected.

The undersigned reserves the right to reject any or all the tenders without assigning any reason thereof. The detailed information/ corrigendum on tender call notice can be available in the District website <https://malkangiri.odisha.gov.in> only.

5. **Documents to be attached :** The following documents should be furnished with the Tender Papers failing which the tender is liable for rejection.

- a) Earnest money deposit pledged in favour of Block Development Officer, Korukonda (as per Para 3 Of DTCN)
- b) Cost Of Tender Paper as per Para 4 Of DTCN
- c) Self attested copy of valid Contractor Registration Certificate.
- d) Self attested copy of valid PAN Card and GST Registration certificates along with up to date GST return filling document.
- e) The bidders have to produce an original affidavit in support of the authenticity of documents including EMD attached with the tender paper.
- f) The Engineer Contractors desirous of availing exemption of EMD should submit an original affidavit as regards the fact of availing award of work without submission of EMD/ISD during the current financial year, otherwise their tender paper will be liable for rejection.
- g) The SC/ST contractors desirous of availing preference should submit an original affidavit in support of caste certificate and self attested copy of caste certificate; otherwise their tender will be liable for rejection.
- h) Joint venture consortium agreements are not allowed to participate in tender.
- i) A Critical Analysis and working procedure must be submitted along with bid paper if the quoted amount is less than the estimate cost by more than 10% for examination by the committee.
- j) The **name of the project** for which tender paper is filed to be written on the **top of cover** in which all the required papers are kept and sealed; else the packet shall not be considered for tender
- k) Certificate to the effect that the tenderer is not related to any JE/AE/AEE of this Block Office
- l) Each sealed cover must contain tender paper for one work only & its related document and the name of the work are written on the body of the cover, otherwise it will not be considered for tender and will be rejected
- m) The rate shall be quoted in words and figures. Otherwise, the tender will be liable for rejection. The tenderer shall be written legibly and free from erasers, over writings, conversion of figures. Corrections, where unavoidable should be made by scoring out, initialing dating and re-writing.

6. Additional Performance Security Deposit: Additional performance Security shall be deposited by the successful bidders, where the bid amount is seriously unbalanced i.e less than the estimated cost put to tender. In such an event, the bidders who have quoted less bid price/rates than the estimated cost put to tender minus the quoted amount as A.P.S.D. in shape of N.S.C. /K.V.P./Post office Saving Account/Post office Time Deposit/Bank Guarantee/E-Bank guarantee duly pledged in favour of Block Development Officer, Korukonda will be deposited at the time of agreement at the following range/rate.

Shortfall if any required document(s), draft(s) and EMD, tender paper is liable for rejection.

7. If the date of sale, receipt and opening of the tender as specified above happens to be holiday(s), then the process of sale, receipt and opening whatsoever will be shifted to immediate next working day at the same specified time and venue respectively without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned Tenderers through notice affixing to Notice Board at Panchayat Samiti, Korukonda only.

8. The details of successful bidders against each work will be displayed in the notice board. The successful bidder will collect the letter of acceptance from the office of the undersigned within seven days from the date of declaration of list of successful bidders on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non-receipt of acceptance letter.

9. The EMD amount is to be forfeited if the tender backs out from the offer acceptance of tender by the competent authority.

10. The appropriate GST shall be paid extra on Tender bid amount of the said projects as and when applicable as per the Govt. norms.

11. Each sealed cover should contain tender paper for one work only & its related documents and the name of work are written on the body of the cover, otherwise it will be rejected.




