ADDENDUM

In view of 36 vacancies in the General Duty (Non-Trade) category and the large number of candidates, considerable time would be required to conduct the **Personality Test** for the Home Guards Enrolment. Hence, the Committee has decided to **shortlist candidates for the Personality Test in the ratio of 1:3**, based on higher combined marks in the **Written and Physical Tests**. Candidates secured with lower marks shall not be considered and **will not be called for the personality test**.

If suitable candidates are not found in the Trade categories as per earlier proceedings, the resultant vacancies shall be filled from the **General Duty (Non-Trade) category**.

All other terms and conditions shall remain unchanged. This shall come into immediate effect.
