SHORT QUOTATION CALL NOTICE

Sealed quotations are invited from reputed and experienced manufacturers/authorized dealers/suppliers for the **supply, delivery and commissioning of One (01) Speed Boat and Five (05) Paddle Boats** for use at Malkangiri under Malkangiri Forest Division.

1. Scope of Supply

(A) Speed Boat – 01 No.

- Type: 6–10-Seater Fibreglass Luxury Boat
- Hull, Deck, Superstructure, Floor, Seats, Roofs etc.: Fiber Reinforced Plastic (FRP)
- Fittings are SS, rubber Fenders & Glass wind seals are provided
- Remote steering arrangement & Canopy
- Engine: Outboard Motor 50 HP
- Length: 5.8 Meters & Breadth: 1.8 Meters
- Capacity: Suitable for patrolling and official use
- Standard safety fittings:
 - Life jackets
 - Life Buoy
 - Anchor with rope
 - Bollards & mooring ropes
 - Navigation lights
 - Fire extinguisher
 - First-aid kit
 - Fuel tank and essential accessories
- To comply with applicable safety and statutory norms

(B) Paddle Boats – 05 Nos.

- Type: Pedal-operated paddle boats suitable for inland water bodies
- Material: FRP
- Capacity: Minimum 2-4 persons per boat
- Features:
 - Comfortable seating arrangement
 - Pedal drive system
 - Basic safety fittings (life jackets, rope, etc.)
- Suitable for recreational and official purposes
- To comply with applicable safety and statutory norms

2. Delivery & Commissioning

- All boats shall be delivered at designated locations under Malkangiri Forest Division.
- The supplier shall make the boats operational and provide basic demonstration/training to the concerned staff.

3. Warranty & Service

- Minimum one (01) year warranty for the speed boat, engine, and paddle boats or as offered by the OEM.

- The supplier shall also provide **Annual Maintenance Service (AMC)** for the speed boat, engine, and paddle boats after the expiry of the warranty period, for a minimum period of one year or as agreed, with details of service schedule and charges to be specified separately.
- After-sales service support during the warranty period shall be ensured.

4. Two-Bid System

The quotation shall be submitted in two separate sealed envelopes:

Envelope-I: Technical Bid

Containing:

- Company profile with GST, PAN, and trade license
- Experience in similar supplies
- Technical specifications and brochures
- Warranty and service support details
- Manufacturer's authorization (if applicable)
- Financial statements of the last two years
- Declaration of non-blacklisting
- Legal compliance declaration

Envelope-II: Financial Bid

Containing:

- Item-wise price quotation including all taxes, delivery, and commissioning charges for:
 - Speed Boat – 01 No.
 - Paddle Boats – 05 Nos.

Both envelopes shall be placed in a single outer sealed cover superscribed: **“Quotation for Supply of 01 No. Speed Boat and 05 Nos. Paddle Boats – Malkangiri Forest Division.”**

5. Terms & Conditions

1. Only the financial bids of technically qualified bidders will be opened.
2. The undersigned reserves the right to accept or reject any or all quotations without assigning any reason thereof.
3. Incomplete or conditional quotations will be rejected.
4. Rates shall be inclusive of all taxes, transportation, and commissioning charges.
5. Delivery shall be completed within the time period specified in the supply order.




