On behalf of the President of India, Commandant 177 Bn BSF will dispose off the unserviceable Defence, CT & S, Govt property, tentage, firefighting, barrack property stores, communication stores, tyres, tubes, batteries and other misc stores held on charge of 177 Bn BSF lying in stores at THQ Chittrakonda, for disposal through Public Auction which will be conducted on 30 April 2026 at 1000 Hrs at 177 Bn BSF THQ Chittrakonda (Odisha) Pin-764052.

2. All interested Parties/Bidders may attend the auction & inspect the store laying at THQ Chittrakonda, Malkangiri (Odisha) on the date and time mentioned above.

3. An amount the articles will be sold/auctioned on the basis of **"WHERE IT IS, AS IT IS BASIS"**

4. The presiding officer reserves the right to sell the stores in a lot or in different lots and reject/accept the auction without assigning any reason.

5. Payment of articles sold, will have to be made by the successful bidders(s) by cash on the spot at the spot at the fall of hammer. The articles will have to be removed from the office premises by the bidders(s) at their own risk/expenses on the same day. Value added tax (GST) @ 18% will be charges extra plus surcharges as applicable.

6. Before connecting the auction each bidders will have to deposit an earnest of Rs.5000/- (Rupees. Five thousand) only in cash, which will be adjusted/refunded immediately after the auction is over. They will also bring their residential proof for proper address.

7. In case, the final bidder fails to deposit the cost of the stores on the spot, his earnest money will be forfeited i.e. will not be refunded.

8. In case any doubt or clarification required by any bidder, decision of the presiding Officers of board of officers will be final.

9. The auction will be held as per departmental rules and regulations. The board of officers who will conduct the auction will have full right to reject or accept the auction of any stores without assigning any reason.

10. If the sufficient members of bidders(s) are not present at the time to auction, the auction will be postponed.

11. No Govt. Transportation will be provided to lift the auctioned store.

12. In case the successful bidder fails to lift the store, from the site of auction within the stipulated time the purchaser is liable for being charged ground rent at the prevalent rates up to a maximum period of 10 days. Thereafter, the amount deposited by him shall be forfeited and store will again be put up for auction.

13. Any doubt/queries, required by any bidders, Presiding officer of the board will give the decision on the spot which will be accepted by all concerned. The decision of the Presiding officers conducting the auction shall be final in all matter.
