CORRIGENDUM

In continuation to Notice Inviting Request for Proposal (RFP) vide No. 1919 dated 08.04.2026 for selection of a consulting firm for establishment of Project Management Unit (PMU), the following amendments/modifications are hereby made:

- 1. Clause 2.2: Fixed Remuneration to Experts**
The existing provision stating that "service charges below 5% and over 15% shall be rejected" stands modified and shall be read as:
"Service charges below 3.75% and over 7% will be rejected."
- 2. Part-2: Financial Proposal – Standard Forms**
The remuneration of Infrastructure Experts (02 numbers) was incorrectly mentioned. The corrected details are as follows:
 - o Remuneration: Rs 65,000/- each (Total: Rs 1,30,000/-)
