INSTRUCTION TO TENDERERS

1. Sealed tenders are invited for **Wholesaler/ Retailers/ firm/ Agencies/ Individual** for supply of Nutritional Kit for the TB Patients of the Malkangiri district under the CDM&PHO-Cum-District Mission Director , Malkangiri.
2. The interested bidder may download the tender document from the website: **<https://Malkangiri.odisha.gov.in>**. The tender will have to be submitted in two parts i.e. **Technical Bid (Cover-A)** and **Financial Bid (Cover-B)**. The formats & documents to be submitted in technical & financial bid are mentioned in the tender document. The bidders should submit their **technical** and **financial** bid **separately in two envelopes** and the two envelopes should be put into **another cover envelop** super scribed as **“Tender for Supply of Nutritional Kit for TB Patients of Malkangiri district in advertisement reference no”**._____ **dtd: _____**”.The Technical & Financial Bid envelopes should be clearly marked as **Technical Bid & Financial Bid** on the top of the relevant envelopes. The tenders (Cover & inner envelopes) should be addressed to:

3. The tender should reach the office of the CDM&PHO-Cum DMD NHM, Malkangiri by **25/05/2026 (1.00P.M) through Speed post, Registered post only**. The tenders will be opened at **11.00 A.M on 28/05/2026 in the office chamber of CDM &PHO, Malkangiri**.
4. The financial bid of those tenders shall be opened whose technical bid are found to be qualified.



Eligibility Criteria

1. The tender must be accompanied by **EMD of Rs.50, 000/-**(Fifty thousand) in technical bid by way of demand draft, drawn on any Nationalized/Scheduled Bank in favor of, **ZSS Non NRHM Account** payable Malkangiri. Tenders not accompanied by earnest money will not be considered. EMD of unsuccessful tenders will be returned without interest on finalization of bid. EMD of successful tenders will be retained as performance security & will be refunded on successful completion of the job without interest after the terms of the agreement.
2. The firm should submit Tender paper cost of Re. 1,000/- (One Thousand) Only in shape of DD in favour **ZSS Non NRHM Account** payable Malkangiri.
3. The **firm/ Agencies / Individual /NGO** should have a valid **GST registration & PAN**.
4. Income tax return copy for **AY 2022-23, 2023-24 & 2024-25**.
5. **GST Registration certificate**.
6. The Preference will be given to the **Wholesaler / Retailers/ firm/ Agencies / Individual** having experience in supply and distribution the Grocery/ Food items to govt./Residential schools, college /govt. institution during the last 3years (If Any).

TERMS AND CONDITIONS FOR OF NUTRITIONAL KIT TO THE TB PATIENTS

- 1.The Wholesaler / Retailers/firm/ Agencies / Individual will supply and distribute Nutritional Kit for the TB Patients of the Malkangiri district as per requirement provided by NTEP Department.
2. The Wholesaler / Retailers/firm/ Agencies / Individual shall supply and distribute the Nutritional Kit to the TB Patients of the Malkangiri district to the designated venue i.e. office of the NTEP, ADPHO(TB) , Malkangiri and block SDH/ CHC/UPHC/PHC/PHI level.
3. The Rate to be quoted as a whole Combination of all categories of items with imprinted Carry bags-at District and Block Level inclusive of taxes & transportation Charges.
5. The CDM & PHO, Malkangiri reserves the right to reject/ consider any such proposal without assigning any reason thereof.
6. The bidders must be Local supplier within area of Malkangiri District. Outside Malkangiri District supplier must submit the Local Office Proof within the Malkangiri Jurisdictions.
- 7.Those Bidders who will qualify in the technical bid, their Financial Bid (Cover B) shall only be opened.
8. That the organization agrees to abide by all terms & conditions of tender.
9. The food items will be packed in a basket/ bag/ box as per the requirement of one patient per month with the NALCO logo.
10. The Wholesaler / Retailers/firm/ Agencies / Individual shall send signature sheet and photographs of the patient receive the food basket at the time distribution.
11. The organization will quote **prices inclusive of all taxes, charges and food basket will be delivered at the doorstep of TB patients within a stipulated time frame**. The CDM & PHO, Malkangiri will have no liability regarding transportation, loading, unloading of materials and all material ordered shall be delivered at the designated place in good condition and fixing the material at institution level as per order. The defective or damaged materials if any have to be replaced by the supplying agency. The delivery must be actual as per quantity ordered which will be verified after delivery and no process damage will be entertained.
12. **The Grocery/ Food items must have minimum 6 months of Expiry date from the date of delivery of the items.**
13. **The bidders have to submit the sample of the Grocery/ Food items. The cost towards the testing of samples will be borne by the bidder himself if any.**

14. The rate approved will be valid for one year from the date of finalisation of tender. The successful bidder is required to provide items as per requirements placed by CDM & PHO, Malkangiri during the valid period of tender.

15. The selected **Wholesaler / Retailers/ firm/ Agencies / Individual** shall distribute the food packet to the sub-centre of each block .A day has been fixed in the first week of each month (preferably the 11th of each month) for distribution of food packets at each Sub-centres in the presence of CHOs, STSs, ASHAs etc.


16.If any information or documents furnished by the bidder is found to be incorrect or misleading at any stage, the tender will be rejected.

17.The blacklisted agencies: either by the Tender inviting authority or by any state Govt. Or Central Govt. organization is not eligible to participate in the tender for that item during the period of blacklisting. (Details in Annexure- C)

18. The bidder shall submit the original tender document with seal and signature on each page as a token of acceptance of terms & conditions. Tender documents in any other form and not completed in all respect shall be summarily rejected. The agency will be whole some responsible for breakage and leakage of during the period of transportation, in such case no payments will get count.

19. Termination: CDM & PHO-cum-DMD, NHM Malkangiri shall have the discretion to terminate agreement / work order at any time by giving **one month notice** whereupon the agency will immediately cease the provision of the Services and submit a bill for costs incurred to provide the contracted services to the date of termination.

20. Payment: The CDM & PHO, Malkangiri will not pay any advance payment to the organisation. The organisation will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in this regard. The approved agency shall have to submit the photographs & certificates from the competent authority after completion of works at block level for release of payment on monthly basis.
