Expression of Interest (EOI) for Selection of Local Self-Help Group (SHG) for Operation and Maintenance of AAHAR Kitchen & Aahar Kendra at Bus Stand Malkangiri

Sealed proposal are invited from the local WSHGs for Operation and Maintenance of Aahar Kitchen & Aahar Centre at Bus Stand, Malkangiri.

The AAHAR Program aims to provide safe, hygienic, and subsidized meals to the public, especially targeting the poor and needy. The selected WSHG will be responsible for day-to-day operations, food preparation, serving, cleanliness, and maintenance of the AAHAR Kendra as per prescribed guidelines. Maintenance of records and timely reporting to the authority. Ensuring quality service and customer satisfaction.

Eligibility Criteria

1. The SHG must be a local group functioning within Malkangiri Municipality areas.
2. The local Self-Help Groups (WSHG) must be registered under NULM / Mission Shakti / ORMAS / Government recognized SHG federations.
3. The WSHG should have experience in community kitchen management, meal preparation, SHG-based livelihood activities, sanitation, housekeeping or other similar service-oriented activities. However, considering that no fresh EOI for operation of AAHAR Kendras has been invited during the last several years, lack of direct experience in operation of AAHAR Kendras shall not be a disqualification. Such SHGs may participate in the selection process, and suitable weightage /preference shall be given to SHGs possessing relevant experience.
4. The WSHG should not be blacklisted or involved in any litigation with any government agency.
5. The WSHG must adhering to **Pancha Sutra** for Group management.

1. Application expressing interest.
2. SHG registration certificate
3. Copy of Aadhaar card of all members
4. Past Experience details (if any) with supporting documents.
5. Bank account details
6. Resolution copy for willingness to take up the work.
7. SHG should submit last 06 (Six) months resolution copy.
8. SHG should submit the last 06 (Six) month cash book copy.
9. SHG should submit last six Month transaction details copy.
10. SHG PAN Card.

Interested SHG may submit their Expression of Interest with relevant documents in a sealed envelope to the office of the Executive Officer-cum-Secretary, District Aahar Society, Malkangiri Municipality on or before 25.06.2026 by 4.00 PM during office hours through Speed post/Regd. Post only.

The same will be opened on 29-06-2026 at 10.00 AM in the chamber of the Undersigned with presence of WSHGs and their authorized agent if present. 
